We will suddenly realize that God is doing for us what we could not do for ourselves." (BIG BOOK, p. 83-84).

The promises have given hope to millions in the grip of their addiction. They encourage us to persevere in our recovery work, for the rewards are beyond our comprehension.

"We are going to know a new freedom and a new happiness." We sample this new freedom and new happiness as we make amends to our fellows whom we have harmed. In doing so we are building the bridge to freedom.

"We will not regret the past nor wish to shut the door on it." Our past is unique; events that occurred may have caused us pain, but we learn from them. How wonderful is it that pain from our past can become useful to us. I do not wish to shut that door of self-learning.

"We will comprehend the word serenity and we will know peace. No matter how far down the scale we have gone, we will see how our experience can benefit others." What joy we have when we help others. Our experience can have such a positive influence on the recovery of others, which can keep us on the path of our own recovery. Sounds like a pretty good deal.

"That feeling of uselessness and self-pity will disappear. We will lose interest in selfish things and gain interest in our fellows." For me, self-pity is a glaring character defect. By gaining interest in our fellows, we're not focusing on ourselves. Self-pity can then take the backseat it so well deserves.

"Self-seeking will slip away. Our whole attitude and outlook upon life will change." Self-seeking places us in the throngs of our illness. I cannot experience joy whenever I do this.

"Fear of people and of economic insecurity will leave us. We will intuitively know how to handle situations which used to baffle us. We will suddenly realize that God is doing for us what we could not do for ourselves." We are so grateful for these promises, for we can face life with the knowledge that our Higher Power will help us to experience them. That encourages us to "Keep coming back! It works if we work it".

Moral Responsibility...

"Some strongly object to the OA position that compulsive eating is an illness. This concept, they feel, removes moral responsibility from compulsive eaters. As any OA knows, this is far from true. We do not use the concept of sickness to absolve our members from responsibility. On the contrary, we use the fact of fatal illness to clamp the heaviest kind of moral obligation onto the sufferer, the obligation to use OA's Twelve Steps to get well.

"In the early days of her food indulging, the compulsive eater is often guilty of irresponsibility. But once the time of compulsive eating has arrived, she can't very well be held fully accountable for her conduct. She then has an obsession that condemns her to compulsively eat, and a bodily sensitivity to certain foods that guarantees her final madness and death.

"But when she is made aware of this condition, she is under pressure to accept OA's program of moral regeneration."

Another Form of Acceptance

For me the Third Step is "Let Go and Let God". It is surrender and this is not easy for me. The BIG BOOK tells us this is not an overnight process. When I first came into program, I had a "God Box". My sponsor suggested this. When things were overwhelming or I seemed unable to cope, I wrote them down and put them in a box, a direct mail box to God.

As time went on, I found that I no longer needed this in-between method. I could surrender things, especially my self will, to God. It is when I give up self that I see the changes God has put before me. When I stop trying to control, my life goes smoothly! What a paradox, to let go is to find.

For me, the Third Step means acceptance of God's will in my life. It is only when I let go and let God that I have a sense of serenity, a sense of contentment with those things going on around me. It is when I give up control that I see the answers God puts before me. I need to stay out of God's way.

It still means I will take action and then surrender the results. I am allowing myself to be in God's hands, to trust that He will be there for me. Every moment I live invites me to both give and receive a particular lesson, usually one I had not planned on. All things prepare me for the next lap in life's adventure. I now take time to smell the roses.
